ALL POEA LICENSED MANNING AGENCIES, SHIPOWNERS, AND TO

PRINCIPAL/EMPLOYERS WITH FOREIGN FLAG SHIPS

Memorandum Circular No. 07, series of 2017 on Financial Security for Foreign SUBJECT:

Flag Ships and Requirements on Enrolment of Ships per 2016 Revised POEA

ILIPPINE OVERSEAS EMPLOYMENT ADMINISTRATION Administrative Branch Central Records Division

Rules on the Recruitment and Deployment of Seafarers

Relative to the above-subject, we wish to inform that the mentioned circular was published in a newspaper of general circulation and will take effect on 16 September 2017.

The financial security document shall be included in the requirements for enrolment of ships stated in the 2016 POEA Revised Rules. The following is the list of requirements for enrolment of ships for submission by licensed manning agency:

1. Certificate of Ship Registry (CSR) indicating the ship's particulars.

For new building ship, Builder's or Owner's certificate and affidavit of undertaking of the licensed manning agency to submit the CSR within thirty (30) days from submission.

- 2. Crew order request
- 3. Salary scale
- 4. Ship's insurance Certificate of Cover (COC) (standard form Annex A) for existing ship and affidavit of undertaking ensuring the continuing validity of the COC (sample affidavit in Annex B).

For new building ship, Affidavit of Undertaking of the agency to submit the COC upon ship delivery and its continuing validity (sample affidavit in Annex C).

5. Financial security document/s compliant with the amendments to the Code implementing Regulations 2.5 and 4.2 and appendices A2-1 and A4-1 of the MLC,2006 and an Affidavit of Undertaking ensuring the continuing validity of the financial security (sample affidavit in Annex D).

For enrolment of new building ship, a copy of valid document of financial security shall be submitted, if available. In its absence, an affidavit of undertaking (sample affidavit in Annex E) on the following shall be submitted:

- To submit a copy of valid document of financial security provided by the shipowner or principal, or P&I of the vessel within 60 days after ship's delivery; and
- To assume responsibility for the deployed seafarers in relation to the items required to be covered by the financial security.

Manning agencies with existing enrolled ship are reminded to submit within sixty (60) days from 16 September 2017, the required proof of financial security with the corresponding Affidavit of Undertaking ensuring the continuing validity of the financial security document (sample affidavit in Annex F).
