The Philippine Overseas Employment Administration wishes to inform that the second leg of the orientation on the 2016 revised POEA Rules and Regulations Governing the Recruitment and Employment of Seafarers for manning agencies will be conducted on October 27, 2017, from 9:00am to 5:00pm at Azia Suites & Residences, located at No.8 Rahmann Extension, Cebu City.
