the Total Deployment Ban to Kuwait

Pursuant to DOLE Administrative Order No. 54 - A, Series of 2018, on the exception of Balik Manggagawa workers from the total ban on deployment of Overseas Filipino Workers to Kuwait, the following guidelines are hereby issued:

A. OEC Processing

The issuance of Overseas Employment Certificate (OEC) for Balik Manggagawa or returning workers exempted from the ban to Kuwait will be thru regular processing at the POEA Main Office, Regional Centers, Satellite Offices, Extension Units and BM Mall Processing Centers. All Balik Manggagawa or Workers On-Leave bound to Kuwait are enjoined to set up an online appointment through the BM Online Processing System on its portal at https://www.bmoline.ph or bmonline.poea.gov.ph. Workers need to log in to their BM online accounts and set an online appointment for their preferred date, time and convenient OEC processing center.

B. Requirements

- Passport valid at least 6 months from date of return to jobsite;
- 2. Valid work visa / igama / civil id:
- 3. Proof of Employment (i.e. valid employment contract, pay slip, valid company id, current employment certificate);
- 4. Plane ticket.

C. Counter Checking Process

The Balik Manggagawa should be a certified returning worker and an active member of Overseas Workers Welfare Administration (OWWA) as can be validated by the POEA and OWWA evaluators at the designated centers.

D. OEC Processing Centers:

The Balik Manggagawa workers shall set an online appointment at any convenient POEA processing center nearest them, as follows:
