


SINGAPORE TRAVEL HEALTH CONTROL MEASURES

Singapore is reopening its borders in a controlled and safe manner to maintain its status as an international hub. Travelers planning to enter the country must comply with the border and health control measures that were updated in response to the evolving global COVID-19 situation.

Travelers approved for entry should refer to the specific requirements and process for the respective Safe Travel lanes (link: https://safetravel.ica.gov.sg/arriving/overview) they are entering Singapore on. These health control requirements would also be stated as conditions of entry approval where relevant.

To minimize the public health risks associated with the border reopening, travelers arriving in Singapore may be required to observe the relevant health control measures, below:

- COVID-19 Tests
 - a. COVID-19 Polymerase Chain Reaction Test ("PCR Test")
 - b. Pre-departure test
- Self-Isolation and Segregation Measures
 - a. Stay-Home Notice (SHN)
 - b. SHN in Dedicated Facilities (SDF)
 - c. SHN Electronic Monitoring Devices
- Mandatory COVID-19 Travel Insurance
- Treatment for Covid-19

As these measures are continually evolving to better respond to the epidemiological developments overseas, travelers planning to visit Singapore should visit the Ministry of Health's (MOH) webpage for the latest information through https://www.moh.gov.sg/covid-19.

Visitors should monitor their health and should not travel to Singapore if they:

a. Have symptoms of COVID-19;

- b. Are diagnosed or suspected to have COVID-19 infection in the last 21 days before departing for Singapore; or
- c. Had close contact with any person with COVID-19 in the last 14 days before departing for Singapore. Close contact means:
 - Providing care for a COVID-19 patient, including in healthcare or family/social setting;
 - Staying in the same place as a person with COVID-19 (e.g. household members); or
 - Close (i.e. less than 2 metres) and prolonged contact (15 minutes or more) with a person with COVID-19 (e.g. shared a meal).

General Entry from All Countries/Regions

For travelers arriving from all countries/regions, the following traveler types and Safe Travel Lanes are applicable for general entry into Singapore:

Returning Singapore Citizen/PR	Singapore Long Term Pass Holder ¹	Family Members of Singapore Citizens/Permanent Residents
Returning Singapore Citizen/PR	 Work Pass Holder Lane Student's Pass Holder Lane 	Singapore Citizen/Permanent Resident Familial Ties Lane

¹ Long Term Visit Pass holders should apply for entry either as a dependent of a Work Pass Holder under the Work Pass Holder General Lane, Parent/Guardian of a Student's Pass Holder under the Student's Pass Holder Lane, or for entry under the Singapore Citizen/Permanent Resident Familial Ties Lane.
