GOVERNING BOARD RESOLUTION No. 04
Series of 2015

WHEREAS, Republic Act 10022 authorizes the POEA Governing Board, after consultation with the Department of Foreign Affairs (DFA), to impose a ban on the deployment of Filipino migrant workers in pursuit of national interest or when public welfare so requires;

WHEREAS, on 20 May 2014, the DFA raised the crisis alert level in Thailand to Crisis Alert Level 2 (Restriction Phase) in view of the declaration of Martial Law due to the escalating civil unrest and insecurity in the country;

WHEREAS, under Alert Level 2, only the processing and deployment of returning OFWs with existing employment contracts shall be allowed and the processing and deployment of newly-hired OFWs shall be suspended;

WHEREAS, on 21 May 2014, Governing Board Resolution (GBR) No. 6, Series of 2014 was issued imposing a temporary suspension on the processing and deployment of newly-hired OFWs bound for Thailand;

WHEREAS, on 16 June 2014, the DFA lowered the crisis alert level in Thailand from Alert Level 2 to Alert Level 1 (Precautionary Phase), lifting the partial deployment ban in Thailand and resuming the processing and deployment thereto of newly hired workers; and


WHEREAS, on 06 April 2015, the DFA further lifted Crisis Alert Level 1 in Thailand in view of the continued improvement of the political and security situation therein as indicated by the lifting of Martial Law in the country.


NOW, THEREFORE, the POEA Governing Board, in a meeting duly convened, **RESOLVES AS IT IS HEREBY RESOLVED**, to affirm the lifting of Crisis Alert Level 1 in Thailand for guidance and dissemination to its publics.
