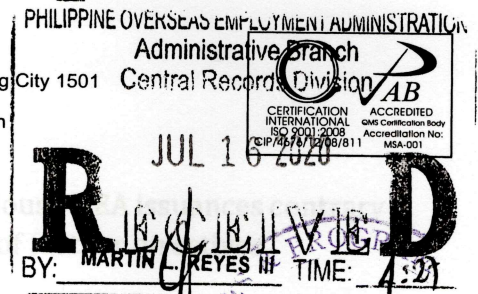

MEMORANDUM CIRCULAR No. 11-C

TO : All Concerned Licensed Recruitment Agencies (LMAs) and Licensed Manning Agencies (LMAs)

SUBJECT : Amendment to POEA Memorandum Circular 11-B, Series of 2020

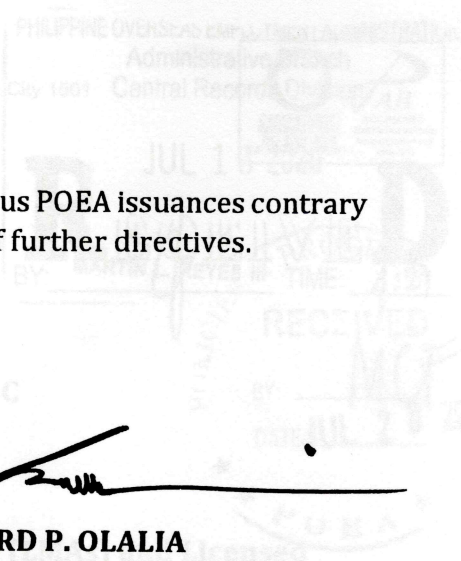
In support to the IATF Resolution No. 36 Series of 2020 which directs government offices to establish "Green Lanes" that will enable licensed recruitment and manning agencies prompt processing and deployment of overseas Filipino workers (OFWs) from both the landbased and seabased sectors, and consistent with other issuances of the POEA and other government offices, POEA Memorandum Circular 11-B, Series of 2020, which amends earlier-issued POEA Memorandum Circulars, is hereby amended as follows:

III. Renewal, Upgrading and Extension of Principal Accreditation. The principal accreditation of LRAs and LMAs whose expiration fall during the period covered by POEA Memorandum Circular No. 7-A Series of 2020 and Memorandum Circular 11-A Series of 2020 are hereby further extended with a validity until 15 August 2020 subject to the following conditions:

1. The availment of extension shall be upon the request of the respective LRAs or LMAs.
2. LRAs and LMAs that will avail of the extension are hereby directed to submit a letter of request to the Director of the Pre-Employment Services Office (PSO) copy furnished the Director POEA ICT Branch signifying their interest to avail of the said extension. Requests should be submitted until 27 July 2020.
3. Availing LRAs and MRAs shall be allowed to submit the documentary requirements and file their appropriate application for either renewal, upgrading or extension at POEA on or before 15 August 2020.
